

Leak Repair Rebate Application

A new program from Anaheim Public Utilities (APU) offers rebates to income-qualified customers who repair water leaks in and around their residences, including but not limited to slab leaks, irrigation system leaks, and faucet leaks. Qualifying customers will be eligible for reimbursement of up to \$250 in expenditures for materials and hired labor required to complete repairs. A customer can request rebates for multiple leak repairs at the same residence on a single Application, and a customer can file subsequent Applications if future repairs are made, subject to a total program cap of \$250.

HOW TO APPLY

- To apply, customer’s household income must be at or below 80% of the Orange County median household income (per US Census), or customer must be a current participant in an APU-sponsored income-qualifying program.
- Complete Application in full and attach the following required documents:
 - A copy of your most recent APU bill
 - Documentation of leak (e.g. spike in water bill, report after inspection of leak by APU staff, invoice documenting leak, details, before and after photos)
 - Copies of invoices, receipts, checks or other documents showing expenditures for repair of leak

Program Guidelines

- A. Customers who are at or below the 80% Orange County median level income, in the city of Anaheim are eligible to participate.
- B. Water leaks to be repaired may include but not be limited to: slab leaks, plumbing leaks, appliance leaks, irrigation leaks, lateral line leaks, etc.
- C. Proof of a leak must be submitted in the form of an unusually high water bill, pictures, inspection of the meter flow indicator or actual leak by APU staff, or other means acceptable to APU staff.
- D. Rebate may only be used for materials and labor for the leak repair.
- E. Labor for the leak repair must be described and priced separately from any other labor provided on the same invoice or receipt.
- F. Proof of repair completion must be submitted in the form of a return to normal consumption shown on the water bill, pictures, inspection of the flow indicator by APU staff, or other means acceptable to APU staff.
